#### **Conditions of Use and Declaration Statement:**

Please complete this consent form and return to the school office.

- 1. This form is valid from the date you sign it, for the period of time your child attends St John's Meads CE Primary School.
- 2. We will not re-use any photographs or recordings after your child leaves St John's Meads.
- 3. We will not use the personal details or full names (i.e. first name and surname) of any child or adult in a photograph without agreement of the parent/guardian.
- 4. If we name a pupil in the text, we will not use a photograph of that child to accompany the article unless this has been agreed by the parent/guardian.
- 5. We will not include personal e-mail or postal addresses, or telephone or fax numbers in our school prospectus or in any other printed publications we may produce without agreement of the parent/quardian.
- 6. If we use photographs of individual pupils, we will not use the full name of that child in the accompanying text or photo caption.
- 7. We may include pictures of pupils and teachers that have been drawn by the pupils.
- 8. We may use group or class photographs, or footage with accompanying text regarding school activities and events for example, church events, offsite activities and visits, sports day, school productions and fundraising events.
- 9. We will only use images of pupils who are suitably dressed, to reduce the risk of such images being used inappropriately.
- 10. We will upload pictures and videos onto Tapestry <a href="https://tapestry.info/">https://tapestry.info/</a> for school assessment. These are secure websites, which require an account linked to our school and parents/carers are provided with a secure login and password.
